It is Mother Teresa Catholic Church's policy to respect your privacy regarding any information we may collect while operating our website. This Privacy Policy applies to [www.motherteresacc.com](http://www.motherteresacc.com) (hereinafter, "us", "we", or "www.motherteresacc.com"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our Website, how we use this information, and under what circumstances we may disclose the information to third parties. This Privacy Policy applies only to information we collect through the Website and does not apply to our collection of information from other sources.

## 1. Website Visitors

Like most website operators, Mother Teresa Catholic Church collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Mother Teresa Catholic Church's purpose in collecting non-personally identifying information is to better understand how Mother Teresa Catholic Church's visitors use its website. From time to time, Mother Teresa Catholic Church may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website. Mother Teresa Catholic Church also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on <https://www.motherteresacc.com> blog posts. Mother Teresa Catholic Church only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below.

## 2. Personally-Identifying Information

Certain visitors to Mother Teresa Catholic Church's websites choose to interact with Mother Teresa Catholic Church in ways that require Mother Teresa Catholic Church to gather personally-identifying information. The amount and type of information that Mother Teresa Catholic Church gathers depends on the nature of the interaction. ## 3. Security

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.

## 4. Links To External Sites

Our Service may contain links to external sites that are not operated by us. If you click on a third party link, you will be directed to that third party's site. We strongly advise you to review the Privacy Policy and terms of service of every site you visit.

We have no control over, and assume no responsibility for the content, privacy policies or practices of any third party sites, products or services.

## 5. Protection of Certain Personally-Identifying Information

Mother Teresa Catholic Church discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Mother Teresa Catholic Church's behalf or to provide services available at Mother Teresa Catholic Church's website, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using Mother Teresa Catholic Church's website, you consent to the transfer of such information to them. Mother Teresa Catholic Church will not rent or sell potentially personally-identifying and personally-identifying information to anyone. If you are a registered user of <https://www.motherteresacc.com> and have supplied your email address, Mother Teresa Catholic Church may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Mother Teresa Catholic Church and our products. We primarily use our blog to communicate this type of information, so we expect to keep this type of email to a minimum. If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Mother Teresa Catholic Church takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

## 6. Aggregated Statistics

Mother Teresa Catholic Church may collect statistics about the behavior of visitors to its website. Mother Teresa Catholic Church may display this information publicly or provide it to others. However, Mother Teresa Catholic Church does not disclose your personally-identifying information.

## 7. Cookies
